How?	All financial companies need to share members' personal information to run their everyday business. How does KC Unidos Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does KC Unidos Federal Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>open an account or show your government-issued ID</li> <li>apply for financing or give us your contact information</li> <li>give us your wage statements</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State law and individual companies may give you additional rights to limit sharing.</li> </ul>	
Definitions		
Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>KC Unidos Federal Credit Union has no affiliates.</li> </ul>	
<ul> <li>Nonaffiliates</li> <li>Companies not related by common ownership or control. They can be financial nonfinancial companies.</li> <li>KC Unidos Federal Credit Union does not share with our nonaffiliates so the market to you.</li> </ul>		
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include insurance companies and loan recapture programs.</li> </ul>
